The meeting was called to order at 7:05 PM. The minutes of the April 18, 2007 meeting were approved. The motion was made by Dave Dignam and seconded by Jim Harrison.

Principal Jeffers opened discussion about a possible ½ cent sales tax referendum to finance the Lemon Bay High School construction project of approximately \$90,000,000. which may be put before the voters in January 2008 or earlier.

Mr. Jeffers spoke about the Kaplan reading program which should be offered to improve skills this coming year. FCAT scoring data was passed out and discussed as to the possible differences between last years Achievement Levels and this. LBHS had less “1” and “2” scores than in the previous year, which is an improvement.

“FAQ’s about LBHS” was distributed to all in attendance and discussion of the new freshman dialog network and the contribution of many hours made by Amber Laneiwski on the project. Mr. Loudon indicated that Manta Mentors would follow up with their students quarterly.

**There was discussion about the availability of large enough facilities for future graduation ceremonies for LBHS. The suggestion of the utilization of the gym was made and that it could hold 1846 people with some modification. Mr. Jeffers indicated that we could expect over 320 students per class from LA Ainger, assuming no growth. A class of 360 would preclude our ability to graduate at Port Charlotte High School.**

**Elections were held for the offices of Chairman, Vice Chairman, and Secretary. Previously nominated for those offices were Andy Dodd as Chairman, Jim Harrison as Vice Chairman, and Teri Rigsby as Secretary. Votes were taken and all were elected.**

**There was discussion about the need to encourage parent participation in school sponsored family education nights and possible incentives to increase numbers in attendance. The Family Focus Night will be resumed during the fall, as well as continuing our Manta University programs, which are more grade specific. The District is also initiating a “Be There” campaign to increase parent involvement.**

**The first meeting date for the 2007-2008 calendar year was set for August 22<sup>nd</sup> at 7:00 PM.**

**A motion was made and seconded to adjourn the meeting at around 7:55 PM.**
